

# 2022-2023 Financial Contract

## K5-12<sup>th</sup> Grade

Please read and **initial items** 1-10, sign and date the bottom of the form and return to the Business Office in person.

\_\_\_\_\_ 1) a) I understand that my child will not be enrolled until the Re-enrollment forms on RenWeb or Online Application are completed in their entirety. b) The non-refundable/non-transferable registration fee has been paid. c) This form has been filled out and signed and d) The Financial Contract is hand delivered to Mrs. Mickie Lewis in the Business Office by a Financially Responsible Party for a brief meeting. \*\*\* Enrollment is pending a confirmation email. This email will guarantee your student's spot.

\_\_\_\_\_ 2) **I further understand that once my child is enrolled, I must notify the Business Office in writing if my child will not attend Berean for the 2022/2023 school year. In the event of an early withdrawal, I understand that I will be responsible for an early withdrawal fee of 2/10 of my child's annual tuition if my child is withdrawn on or after June 1, 2022. I understand that if I withdraw my child prior to May 31, 2022, a \$50 withdrawal fee will be applied to my account.**

\_\_\_\_\_ 3) I understand if I pay by credit card/debit card there will be a 2.85% fee per transaction.

\_\_\_\_\_ 4) There will be NO REFUNDS for fees and partial months of tuition. If a student attends one day in any given month, you will be charged for the full month. A late fee will be assessed after the 1st of each month. **Late fees are billed per student not by family.** Billing is on a monthly installment plan for K5-12<sup>th</sup> grades. **All payments are due the 1st day of the month.** I understand that ALL the school fees that apply to my account are non-refundable and non-transferable once they have been billed. These fees as well as discounts for early payments can be found on the Financial Information Sheet on page two of this document.

\_\_\_\_\_ 5) Report cards will be held and access to RenWeb denied if the account becomes outstanding during any grading period until the account has been paid in full. If a check is returned to Berean for any reason, it must be replaced with cash, cashier's check, or money order within five days of notification along with the return check fee. Academic records will not be released to any person or institution until the account is paid in full. **To get records right away final payment must be paid by one of the following methods of payment-cash, cashier's check, or money order. Otherwise, there will be a 10 day hold to process by check.**

\_\_\_\_\_ 6) **AT THE POINT AN ACCOUNT BECOMES 30 DAYS IN ARREARS; YOUR STUDENT CAN NOT ATTEND CLASS UNTIL THE ACCOUNT IS CURRENT. THE ACCOUNT MUST BE PAID IN FULL IN ORDER FOR THE STUDENT TO RETURN TO CLASS.**

\_\_\_\_\_ 7) Parents are responsible for obtaining all Handbooks, Registration Forms, Financial Information Forms and Policy Sheets for all billable items. This includes but is not limited to athletics, aftercare, and food services. Berean will make every effort to disburse this material, but it remains the parents' responsibility to acquire these documents. Berean will provide access to these documents via RenWeb, website and/or School Lobby.

\_\_\_\_\_ 8) The undersigned hereby promises to pay all costs of collection for any delinquent accounts involving their child, including reasonable attorney's fees, whether suit be brought or not and whether such costs of collection are normally allowed as court costs or not.

\_\_\_\_\_ 9) If, at any time, I feel it necessary as a school parent to pursue legal action against Berean Christian School in a court of law, and if a judgment is handed down in the favor of Berean Christian School, I agree to pay, in full, all legal and attorney fees, court costs, and all other expenses that the school may incur as a result of my action.

\_\_\_\_\_ 10) **I understand that if I withdraw my student for the 2022/2023 school year, I will pay a 2-month tuition fee before receiving any records.**

## • **Registration Fees (non-refundable):**

### **Returning Students:**

- \$300.00 – if re-enrolled by 1/31/22 (\$900 max per family)
- \$350.00 – if re-enrolled by 2/28/22 (\$1,050 max per family)
- \$425.00 – re-enrolled on or after 3/1/22 (\$1,275 max per family)

### **New Students: OPEN ENROLLMENT BEGINS 02/1/22**

- \$25 Application Fee due at the time of application
- \$75 Testing Fee due on the day of testing (in **cash**)
- \$300.00 Registration Fee due at time of enrollment (\$900 max per family)

## **ESE Services:**

- K5-6<sup>th</sup> Grade - 1 Subject \$3,500.00
- ESE English Class (7<sup>th</sup>-12<sup>th</sup>) \$1,500.00
- ESE Math Class (7<sup>th</sup>-12<sup>th</sup>) \$1,500.00
- ESE Learning Strategies: Learning Strategies \$1,500.00  
Class is optional for all 7<sup>th</sup>-12<sup>th</sup> Grade ESE students based on the recommendation of the BCS ESE Department, but mandatory with an accommodation of extended time.
- Accommodations only \$200.00

## **Payment Options:**

- 2% Discount for bi-annual tuition payment if paid by 6/6/22 and 12/6/22
- 4% Discount for annual tuition payment if paid by 6/6/22
